COLLECTION OF DUTIES & TAXES ON 30TH & 31ST MAY, 2017 BY NBP

In view of the bulk collection of duties and taxes in last days of month, it is advised to ensure compliance of the following operational instructions for 30th & 31st May, 2017 with regard to collection of duties and taxes transactions on month end.

- The authorized NBP branches (A, B&C) will remain open on 30th & 31st May, 2017 till 04:00 pm and 05:00 pm respectively.
- The duties and taxes collected by NBP branches on 30th May, 2017 shall be settled with State Bank of Pakistan on 31st May, 2017 positively. While the cash transactions for duties and taxes collected by NBP branches on 31st May, 2017 shall be settled by NBP on same day, within 2 hours of close of business day, i.e. by 07:00 pm, with respective office of State Bank of Pakistan.

Please ensure the meticulous compliance of the above instructions.
