<b>Reason for Suspension</b>	Non-compliance of the provisions of section 3, 8, 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
<b>Tax Periods:</b>	2014-15,2015-16 and 2016-17

Brief facts of the case are that M/s. M/s Fugro Geodetic Limited bearing SNTN No. S1000709-1 are registered with SRB as a service provider in respect of Surveyors services which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 9819.5000.

2. Scrutiny of Bank Statements revealed that they failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the 2011-Act") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the 2011-Rules") and failed to e-file the SST returns as required under section 30 read with Rule 11, 12, 13 and 14 of the said Rules-2011 pertaining to the tax periods of 2014-15, 2015-16 and 2016-17.

3. Accordingly, notice dated 13<sup>th</sup> March, 2019 was served upon the registered person under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011, whereby the registration of M/s Fugro Geodetic Limited was suspended for violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provisions of the Act-2011 and the Rules made thereunder before 22-03-2019 failing to which the case shall be preceded for cancellation of registration.

4. On 11.05.2019 and 18.05.2019, authorized representative of M/s. Fugro Geodetic Limited namely Mr. Muhammad Abdul Hafeez Khan has appeared and submitted the reconciliation data for the tax period of 2014-15, 2015-16 and 2016-17 and the prayer was made to revoked the instant suspension of their tax profile and authorized representative has undertaken that, the registered person is

willing to participate with positive intent in the proceedings under section 23 of the Act, 2011 pending within undersigned's jurisdiction.

5. **In view of the above request, I hereby order for the revoke of suspension with immediate effect as imposed vide this office letter dated 13<sup>th</sup> March, 2019.** The registered person is advised to participate and join the legal proceedings pending before undersigned under section 23 of Act, 2011, as required by the existing law.
