



ORDER FOR WITHDRAWAL OF SUSPENSION

Name & NTN of the Registered Person Suspended:	M/s. Systech Engineering Solutions (Pvt) Ltd SNTN-S3970470-0
Address:	Plot B-174, Sector 6F, Mehran Town, Korangi Industrial Estate, Karachi
Date of Institution:	12-09-2019
Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	Feb-2019 to July-2019 for failure of filing return and March-2019 to July-2019 for failure of depositing due SST.

Brief facts of the case are that M/s. Systech Engineering Solution (Pvt.) Ltd bearing SNTN No. S3970470-0 are registered with SRB as a service provider in respect of Workshop For Industrial Machinery, Construction And Earth-Moving Machinery Or Other Special Purpose Machinery, Etc. which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 9820.2000.

2. Scrutiny of the tax profile of M/s Systech Engineering Solutions (Pvt) Ltd revealed that they failed to deposit the SST for the tax period March-2019 to July-2019 as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the 2011-Act") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the 2011-Rules") and failed to e-file the SST returns for the tax period Feb-2019 to July-2019 as required under section 30 read with Rule 11, 12, 13 and 14 of the said Rules-2011

3. Accordingly, notice bearing NO.SRB-COM-I/AC-29/2019/MW/62 dated 12-09-2019 was served upon the registered person under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 whereby the registration of M/s. Systech Engineering Solution(Pvt). Ltd was suspended for violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provisions of the Act-2011 and the Rules made thereunder failing to which the case would have been proceeded for cancellation of registration.

4. On 1-10-2019, Mr Shakil Ahmed from M.S Consultants appeared on behalf of M/s Systech Engineering Solutions (Pvt) Ltd and submitted original pay order in favor of Sindh Revenue Board in respect of SST for the tax periods Feb-2019 to Aug-2019. Details are as under.
