Subject: **ORDER FOR PROVISIONALLY RESTORATION OF SST REGISTRATION NO. S8947020-3 IN RESPECT OF M/S SHAHAB & CO. (PVT.) LIMITED.**

Please refer to the hearing conducted on 9<sup>th</sup> December, 2021, in the office of the undersigned, in connection to the suspension notice No. SRB/Unit-3/Shahab & Co/2021-22/43809 dated 24<sup>th</sup> November, 2021 issued by this office on failing to deposit due amount of SST, in addition to, failing to perform obligation required under the Sindh Sales Tax on Services Act, 2011, and the rules made thereunder.

02. Mr. Munneeb Iqbal, Assistant Finance Manager having CNIC # 42201,7985172-1 and Syed Faizan, Finance Manager having CNIC # 42201-8420884-7, of M/s. Shahab & Co. (Private) Limited having SNTN # S8947020-3 appeared on behalf of the Company and informed that they are negotiating with their client *i.e.* M/s Maskatiya Industries (Private) Limited for payment of remaining amount of Sindh sales tax (SST), as the contract has already been completed by them and neither SST amount was incorporated in the said contract nor collect from their client.

03. The undersigned invited the attention of the representatives of the Company to the provisions of section 3(1) read-with section 9(1) of the Act, 2011, which hold solely responsible to the Company to charge, collect and deposit SST amount, at the applicable rate, into Government treasury.

04. After detail discussion, the representatives informed and assured this office that, since their dialogues with their aforesaid client are ongoing on the subject levy of SST and it will be concluded within one month and they are hopeful that some meaningful outcome shall come after discussion with their client. They further requested this office to restore their Sindh sales tax registration as they are facing hurdles in performing their business activity, till the outcome of their discussion regarding levy of SST with their client is not finalized.

05. Keeping a lenient view, I have considered the aforesaid request of the representatives of M/s Shahab & Co. (Private) Limited and concluded that, on suspension of registration of the registered person, the complete tax profile of registered person has been blocked on *e.srb* portal for retrieving the data and the taxpayer neither can e-file the returns nor can generate the PSID on its SNTN. Therefore, for the purpose of carrying on their business activity and submission of proper reply against aforementioned notice, the suspension of the registered person is provisionally restored with immediate effect.
